(The Qanoon e Shahadat Order, 1984)

- Q. No. 9** The oral evidence must be direct. Is there any exception to this rule? Discuss in detail. **(15 Marks)**
- Q. No. 10** What is the evidentiary value of evidence that has become available because of modern devices in civil cases? **(15 Marks)**
- Q. No. 11** Hostile witness is a special kind of witness under the QSO. Discuss his characteristics as to examination and value of his evidence. **(15 Marks)**

- Q. No. 3** A public servant taking gratification other than legal remuneration in respect to an official act is an offence. Discuss law relating to gratification under provisions of PPC? **(20 Marks)**
- Q. No. 4** Discuss scope of Sections 462-J, 462 K. and 462 -L and 462-O of PPC. **(20 Marks)**
